This syllabus is a step-by-step lesson plan for your instrument rating training. It is intended to be used in conjunction with the following six Gleim books:

Instrument Pilot FAA Knowledge Test Prep Instrument Pilot Flight Maneuvers and Practical Test Prep Instrument Pilot ACS and Oral Exam Guide Aviation Weather and Weather Services Pilot Handbook FAR/AIM

Your flight instructor (or flight school) will retain a copy of each flight lesson page in this book (and/or make use of the Gleim Instrument Pilot Training Record) as you complete the flight lesson. If a copier is not available at the conclusion of your flight lesson, bring a copy of the completed flight lesson page to the next flight lesson.

#### WHAT ELSE DO YOU NEED?

If you purchased this syllabus as part of the Gleim **Instrument Pilot Kit**, you will need IFR low en route and instrument approach charts. Sources for charts include

- 1. **Aeronautical Information Services.** The FAA's Aeronautical Information Services is the aeronautical charting authority for the development, publication, and dissemination of aeronautical charts. Printed FAA IFR charts may be purchased through online vendors as well as some fixed-base operators (FBO) at a local airport.
- 2. **Jeppesen Sanderson, Inc. (JEPP)**, is a private competitor to the FAA's chart publications. It is the most widely used chart service, and the graphic presentation of its charts differs from that of FAA charts in a number of respects. However, the information is furnished by the FAA.

Appendix C, "IFR Aeronautical Charts," in the *Instrument Pilot Flight Maneuvers and Practical Test Prep* book has more information on the basic IFR charts and how to order the charts.

Additionally, you will need to purchase a copy of the Pilot's Operating Handbook (POH) (sometimes called an Information Manual) for the make and model of your training airplane. Alternatively, you may make a photocopy if the POH is not available for purchase.

#### REQUIREMENTS FOR AN INSTRUMENT RATING

You must meet a number of requirements to earn your instrument rating. The final step is your FAA practical test, which will be conducted by an appropriate evaluator. Your practical test will consist of an approximately 1- to 2-hour oral exam followed by a 1- to 2-hour flight test. You will be well prepared for your practical test by your CFII and your Gleim pilot training materials. In addition, you must meet the following requirements:

- 1. Hold at least a private pilot certificate with an airplane category rating and single-engine class rating.
  - a. Part 61 students must have logged 50 hours of cross-country pilot-in-command time. This is not required of Part 141 students.
- 2. Be able to read, write, and converse fluently in English (certificates with operating limitations may be available for medically related deficiencies).
- 3. Hold a current FAA medical certificate.
  - a. Your medical exam will be conducted by an FAA-designated aviation medical examiner (AME).
  - b. Ask your CFII or call your local flight school for the names and telephone numbers of the AMEs in your area, or visit www.faa.gov/pilots/amelocator for a listing of AMEs by state and city.
  - c. Use the FAA MedXPress system to create an account and complete the initial portion of the application before you meet with your AME.
    - 1) Access the system at http://medxpress.faa.gov.
- 4. Pass your FAA instrument rating airman knowledge test, which consists of 60 multiple-choice questions administered at an FAA-designated computer testing center. Everything you need to prepare for your FAA instrument rating (airplane) airman knowledge test is in your Gleim *Instrument Pilot FAA Knowledge Test Prep, Instrument Pilot Flight Maneuvers and Practical Test Prep, FAR/AIM, Pilot Handbook,* and *Aviation Weather and Weather Services* books. The Gleim FAA Test Prep Online will facilitate your study. (To find out exactly what to expect from the computer testing center of your choice, use the FAA Test Prep Online's convenient vendor emulation testing format.) Use the Gleim Online Ground School for convenient, complete knowledge test study from any computer with Internet access.
  - We have estimated 30 hours to completely prepare for your instrument rating airman knowledge test. See "Instrument Rating Syllabus Lesson Sequence and Times" on page 10.
  - b. The further you study for your FAA instrument rating airman knowledge test before you commence your flight lessons, the better!
    - 1) Under Part 141, you should be enrolled in the school's instrument rating course before beginning your study program.
- 5. Undertake flight training as described in Lessons 1 through 29. Many of the lessons may require more than one flight to complete. We also have provided space for your instructor to record extra flights within each lesson as needed to make you comfortable and proficient.
  - a. It's fun to be successful! Be overly prepared before you get to the airport for each flight lesson.



The KEY TO SUCCESS in your flight training, which also minimizes cost and frustration, is your study and preparation at home before flying with your flight instructor. The more you know about flying, flight training, and each flight lesson, the better you will do.

6. PASS your FAA practical test. See Study Unit 3 (in Part I) in *Instrument Pilot Flight Maneuvers and Practical Test Prep*.

For additional detail regarding FAA instrument rating requirements, refer to the Introduction in the *Instrument Pilot FAA Knowledge Test Prep* book or pages 2 and 3 in the *Instrument Pilot Flight Maneuvers and Practical Test Prep* book.

- 2. Read this Introduction (13 pages).
- 3. Obtain a current and valid medical certificate (if necessary).
- 4. Begin preparing for your FAA instrument rating airman knowledge test by using your Gleim books, **FAA Test Prep Online**, and/or **Online Ground School**. See your ground training syllabus.
- 5. Select a CFII and/or flight school. See Study Unit 1 in *Instrument Pilot Flight Maneuvers* and *Practical Test Prep*.
- 6. Begin your flight training, scheduling at least two lessons a week. Prepare thoroughly at home for each flight lesson. Use the flight training syllabus in this book.

#### PART 141 VS. PART 61 SCHOOLS

Title 14 of the Code of Federal Regulations (14 CFR) lists the requirements to obtain your instrument rating. Pilot (or flight) schools can conduct your training by following either 14 CFR Part 141 or 14 CFR Part 61.

An eligible pilot school may be issued a Part 141 pilot school certificate by the FAA after completion of an application process. Part 141 pilot schools are more regulated than Part 61 pilot schools. Additionally, a Part 141 pilot school is required to have its facilities and airplanes inspected and the ground and flight training syllabi approved by the FAA.

The majority of pilot schools, and flight instructors not associated with a Part 141 pilot school, provide the required training specified under Part 61. Part 61 pilot schools do not require FAA approval. Part 61 requires 40 hours instrument time and 50 hours of cross-country flight time as pilot in command (PIC).

The major difference between a Part 141 and a Part 61 pilot school is that Part 141 requires an FAA approval and 35 hours of instrument time. Part 141 does not have a minimum cross-country experience requirement.

The Gleim syllabus has been reviewed by the FAA in Washington, D.C., and was found to meet the requirements of a syllabus under Part 141 or Part 61, as appropriate. However, final approval of a syllabus for use under Part 141 must come from the responsible Flight Standards office. Thus, the Gleim *Instrument Pilot Syllabus* can be used by any Part 141 school with minimum effort. We suggest that the school write a letter to its FAA inspector advising the FAA of the school's intent and the names of students who are going to be trained under this Gleim syllabus.

If a Part 141 pilot school cannot or will not use this syllabus, consider finding another Part 141 or Part 61 school for your training, OR please call (800) 874-5346 if you have guestions or problems.

#### **PART 141 STUDENT INFORMATION**

#### **Enrollment Prerequisites**

You must hold at least a private pilot certificate, with an airplane category and single-engine land class, prior to enrolling in the flight portion of the instrument rating course. Have your CFI make a photocopy of the enrollment certificate on page 115 of this syllabus and complete it during your first lesson.

#### **Graduation Requirements**

You must complete the training specified in this syllabus, with a minimum of 30 hours of ground training in the specified aeronautical knowledge areas and a minimum of 35 hours of flight training. These requirements are reflected in the Gleim ground and flight training syllabus. At the completion of your training, your CFI should photocopy and complete the graduation certificate on page 117 of this syllabus.

#### **Stage Checks**

You must score a minimum of 80% on the knowledge test at the completion of each stage in the ground training syllabus and on the comprehensive end-of-course knowledge test at the conclusion of the ground training.

You must satisfactorily complete a stage check at the completion of each stage of the flight training syllabus, as well as a comprehensive end-of-course check when all flight training is complete.

#### **Credit for Previous Training**

You may be given credit towards this instrument rating course for previous pilot experience and knowledge 14 CFR 141.77(c):

- 1. If the credit is based on a Part 141 training course, the credit may be 50% of the requirements for this course.
- 2. If the credit is based on a Part 61 course, the credit cannot exceed 25% of the requirements for this course.

The receiving school will determine the amount of course credit to be given, based on a proficiency test, a knowledge test, or both.

#### **GLEIM INSTRUMENT PILOT SYLLABUS**

This syllabus consists of a ground training syllabus and a flight training syllabus. The ground and flight training may be done together as an integrated course of instruction, or each may be done separately. However, if an FSTD (flight simulation training device) or an ATD (aviation training device) is used, the ground and flight instruction must be accomplished as an integrated course of instruction. If done separately, the ground syllabus may be conducted as a home-study course or as a formal ground school.

This syllabus was constructed using the building-block progression of learning, in which the student is required to perform each simple task correctly before a more complex task is introduced. This method will promote the formation of correct habit patterns from the beginning.

Introduction 5

#### **Ground Training Syllabus**

The ground training syllabus contains 11 lessons, which are divided into three stages. The ground training syllabus meets the training requirements of Appendix C to Part 141 and 14 CFR 61.65(b). The ground training can be conducted concurrently with the flight training, with the ground lessons completed in the order as outlined in the lesson matrix. Ground training may also be conducted as part of a formal ground school or as a home-study program.

It is recommended that the lessons be completed in sequence, but the syllabus is flexible enough to meet the needs of an individual student or of a particular training environment. When departing from the sequence, the instructor is responsible for considering the blocks of learning affected and, if used by a Part 141 pilot school, whether it would affect FAA approval.

Each ground lesson involves studying the appropriate section in the Gleim *Instrument Pilot Flight Maneuvers and Practical Test Prep*, *Aviation Weather and Weather Services*, *FAR/AIM*, and *Pilot Handbook*. After each study assignment is completed, you need to answer the questions in the appropriate study unit in the Gleim *Instrument Pilot FAA Knowledge Test Prep* book and review incorrect responses with your instructor.

Alternatively, the Gleim **FAA Test Prep Online** can be used to answer the questions at the end of each ground lesson. Our software contains the FAA figures and outlines in addition to the questions.

FAA Test Prep Online allows you to select either STUDY MODE or TEST MODE. In STUDY MODE, the software provides you with an immediate explanation of each answer you choose (correct or incorrect). You design each study lesson by choosing the conditions. In TEST MODE, the software can emulate the operation of the FAA-approved computer testing centers. Thus, you will have a complete understanding of exactly how to take an FAA instrument rating airman knowledge test before you go to a computer testing center. When you finish your test, you can study the questions missed and access answer explanations.

A third option for ground study is the Gleim **Online Ground School (OGS)**. OGS uses a similar approach to a traditional ground school in that each lesson is presented in order and divided into stages, per the syllabus book. The course contains audiovisual presentations, detailed study material, and quizzes for maximum retention of the information covered.

Because OGS is a self-study program delivered via the Internet, the classroom is always open, so you can study as it fits in to your schedule. When you complete the program and pass the end-of-course knowledge test, an endorsement will be provided to you that will enable you to take the FAA knowledge test at a testing center. This feature makes OGS especially valuable to those users electing to complete their ground training before beginning flight training.

At the end of each stage, you are required to complete the stage knowledge test before proceeding to the next stage. The end-of-course knowledge test is completed after the stage three knowledge test. Shortly after the end-of-course test, you should take the FAA instrument rating airman knowledge test. The stage knowledge tests in the ground syllabus will refer you to FAA figures found after the end-of-course knowledge test in this syllabus.

If this ground training is used as home study, we recommend that you complete the ground syllabus as quickly as possible and pass the FAA instrument rating airman knowledge test so you will have more time to prepare for your flight lessons.

#### Flight Training Syllabus

The Part 141 flight training syllabus contains 29 lessons, which are divided into three stages. It is recommended that each lesson be completed in sequential order.

Stage one of the flight training syllabus is designed to provide you with a foundation of attitude instrument flying skills.

Stage two is designed to provide you with the knowledge and skills required for holding procedures and instrument approach procedures.

Stage three is designed to provide you with practical experience in IFR cross-country flights and preparation for the FAA instrument rating practical test.

**Stage checks.** Stage checks are designed to ensure that you have acquired the necessary knowledge and skill. The stage one check (Lesson 13) is to ensure that you are proficient in attitude instrument flying. The stage two check (Lesson 23) is to ensure that you are proficient in holding procedures and instrument approach procedures. The stage three check (Lesson 28) is to ensure you are proficient in IFR cross-country flights. The end-of-course test (Lesson 29) is to ensure you are proficient in all instrument knowledge, risk assessment, and skill areas and are ready for the instrument rating practical test. It is also the final evaluation for a Part 141 graduation certificate.

The chief instructor (for the Part 141 training course) is responsible for ensuring that each pilot accomplishes the required stage checks and the end-of-course test. The chief instructor may delegate authority for conducting stage checks and the end-of-course test to an assistant chief instructor or a check instructor.

Stage checks will be used as a review by instructors conducting training under Part 61 to ensure that you have the appropriate knowledge and skills.

**Sequence of a flight lesson.** Each flight lesson will begin with a preflight briefing. During this time, your instructor should first answer any questions you may have from the previous lesson. Next, your instructor will brief you on the lesson content, followed by an evaluation of your preparation for the lesson.

During the flight portion of the lesson, your instructor should begin with those maneuvers listed as "review items" before introducing new maneuvers. The time required for each lesson will vary depending on the airport and the location of the training areas.

At the end of each lesson, your instructor will conduct a postflight critique and a preview of the next lesson. This time should be used to review the good points during the lesson, to identify and explain fully any problem areas, and to discuss how to correct the problems. In addition, it is a time for you to ask any questions you have about the flight.

The length of the preflight briefing and postflight critique will vary with each pilot and with his or her degree of preparedness for the lesson.

**Repeating lessons.** A flight lesson in this syllabus is considered complete when all review and/or new lesson items have met the completion standards for the lesson. If some items do not meet the standards or are simply not covered, those items must be completed to the applicable standards before the lesson is considered complete and before the student can move on to the next flight lesson.

You will notice multiple checkboxes beside lesson items in the syllabus book and even more in the training record to allow for multiple lesson attempts. It should not be assumed that a student's instrument training will take only 29 flight lessons simply because that is the number of lessons in the syllabus. It is likely and planned for that students will occasionally need to repeat lessons or certain items from lessons during this course of training.

**Pilot preparation.** The key to minimizing frustration and costs is preparation. You should budget an average of 2 to 4 hours of home study prior to each flight lesson. Learning will be easier when you are fully prepared so that your instructor can maximize the time spent in flight training.

## USE OF A FLIGHT SIMULATION TRAINING DEVICE (FSTD) OR AN AVIATION TRAINING DEVICE (ATD)

While the Gleim *Instrument Pilot Syllabus* was designed to be used in a course of training using only an airplane, it may also be used in a course of training in which the use of a qualified and approved FSTD or ATD has been appropriately integrated with the approval of the responsible Flight Standards office. FSTDs include full flight simulators (FFSs) and flight training devices (FTDs). Aviation training devices (ATDs) include basic (BATD) and advanced (AATD) training devices.

The requirements for using an FFS or FTD in a Part 141 FAA-approved pilot training course are discussed in 14 CFR 141.41(a). FFSs and FTDs are evaluated and qualified under 14 CFR Part 60 and require annual renewal. The requirements for using an ATD are discussed in 14 CFR 141.41(b). The approval and use of an ATD is prescribed in AC 61-136. ATDs must be accompanied by the FAA letter of authorization (LOA) and are valid for 60 calendar months.

An FSTD or ATD may only be used in accordance with the authorization for each specific device. Generally, an ATD may not be used for credit toward the following types of aeronautical experience: cross-country, night, solo, lessons requiring specific quantities of takeoffs and landings, or to meet the requirement to have 3 hours of instruction within 2 calendar months of a practical test.

All training time in an FSTD/ATD must be provided by an authorized flight instructor and documented in accordance with 14 CFR 61.51. There are no restrictions on the amount of training time that may be accomplished and logged in an FSTD/ATD; however, there are regulatory limitations on the maximum credit allowed in an FFS, FTD, or ATD toward the "minimum" pilot experience requirements. Training under Part 141 in an FSTD/ATD may be credited up to the maximum time in the table below toward the 35-hour training time requirement for an instrument rating.

Device	Allowance	Hours
FFS (Part 141)	50%	17.50
FTD (Part 141)	40%	14.00
AATD (Part 141)	40%	14.00
BATD (Part 141)	25%	8.75

The specific lessons that can be accomplished in an FFS, FTD, and/or ATD are indicated with the words "FSTD/ATD option" under the lesson title. If an FSTD/ATD is available, the instructor and student should work together to determine which lessons would provide the greatest benefits while still meeting FAA requirements.

A pilot school operating under Part 61 may also elect to use an FFS, FTD, or ATD in accordance with the specific authorization for that use as outlined in the various sections of Part 61 [such as a maximum of 20 hours of flight training under 14 CFR 61.65(i)]. Time with an instructor in a BATD and an AATD may be credited toward the aeronautical experience requirements for the instrument rating as specified in the LOA for the device used. For more information, refer to the Instrument Rating Airman Certification Standards, Appendix 8, "Use of Flight Simulation Training Devices (FSTD) and Aviation Training Devices (ATD)."

#### AIRPLANE AND LOCAL AIRPORT(S) WORKSHEETS

During your instrument training, your CFII will provide you with the appropriate aircraft power settings and configurations to produce the desired performance. Applying this information is called "flying by the numbers" or the PAC (power setting, altitude, and configuration) method. Use the airplane worksheet to fill out the power and configuration to obtain a desired performance (e.g., 100 kt., VSI ± 500 fpm) for all phases of instrument flight. The local airport(s) worksheet is to be used as a study reference of radio frequencies, runway lengths, and types of approach(es) available at your primary airport and any other local airports you may use during your training.

#### **INSTRUMENT RATING SYLLABUS LESSON SEQUENCE AND TIMES**

The Ground Syllabus follows on pages 15 through 35 and the Flight Syllabus follows on pages 37 through 70.

The table on the following pages lists the sequence of the flight and ground lessons and the minimum time for each lesson. The times listed are for instructor/student guidance only and are not meant to be mandatory times. These times will ensure that the minimum time requirements for aeronautical knowledge and flight training are in compliance with Part 141, Appendix C, Instrument Rating Course.

14 CFR 61.65, Instrument rating requirements, requires that you have logged at least 50 hours of cross-country time as pilot in command (of which 10 hours must be in an airplane). A total of 40 hours of actual or simulated instrument time in the areas of operation listed in 14 CFR 61.65(c) is required, of which 15 hours must have been received from an authorized instructor. This instrument time must include 3 hours of instrument flight training within 2 calendar months before the date of the practical test and a 250 NM IFR cross-country flight with a total of 3 approaches. Thus, if you are conducting your training under Part 61, you and your instructor must add at least 5 additional instrument flight training hours to the 35-hour total in the following table. Additionally, you are responsible for ensuring that you have 50 hours of cross-country time as pilot in command. Gleim leaves the selection of which lessons to add up to the student/instructor to ensure the appropriate content is covered for each student.

Each training flight must include a preflight briefing and a postflight critique of the pilot's performance by the instructor.

If you are using a flight simulation training device or aviation training device, the columns under BATD, AATD, and FFS represent a sample recommended sequence of lessons that can maximize use of simulator time. These are not the only lessons for which a simulator may be used. For more information, including definitions and approvals for the use of various types of simulators under Part 61 or 141, refer to Appendix B, starting on page 111.



#### FLIGHT TRAINING COURSE OBJECTIVES

The pilot will obtain the aeronautical knowledge and experience and demonstrate the flight proficiency necessary to meet the requirements for an instrument rating with an airplane category rating.

#### FLIGHT TRAINING COURSE COMPLETION STANDARDS

The pilot will demonstrate through the stage checks and school records that (s)he has the necessary flight proficiency and aeronautical experience to obtain an instrument rating with an airplane category rating.

The following is a brief description of the parts of each flight lesson in this syllabus:

**Objective:** We open each lesson with an objective, usually a sentence or two, to help you gain perspective and understand the goal for that particular lesson.

**Text References:** For lessons with new learning items, this section tells you which reference books you will need to study or refer to while mastering the tasks within the lesson. Abbreviations are given to facilitate the cross-referencing process.

**Content:** Each lesson contains a list of the tasks required to be completed before moving to the next lesson. A task may be listed as a "review item" (a task that was covered in a previous lesson) or as a "new item" (a task that is introduced to you for the first time). Each task is preceded by three blank "checkoff" boxes, which may be used by your CFI to keep track of your progress and to indicate that each task was completed.

There are three boxes because it may take more than one flight to complete the lesson. Your CFI may mark the box(es) next to each task in one of the following methods (or any other method desired):

The last task in each flight lesson is labeled "Additional items at CFI's discretion," and is followed by several blank lines. This area can be used to record any extra items that your CFI feels are appropriate to the lesson, taking into account such variables as weather, local operational considerations, and your progress as a student.

NOTE: CFIs are reminded not to limit themselves to the blank lines provided—use as much of the page as you need.

**Completion Standards:** Based on these standards, your CFI determines how well you have met the objective of the lesson in terms of knowledge and skill.

**Instructor's Comments and Lesson Assignment:** Space is provided for your CFI's critique of the lesson, which you can refer to later. Your instructor may also write any specific assignment for the next lesson.

#### **Reading Assignments for Flight Lessons**

You are expected to be prepared for each flight lesson. Our reading assignments include text references for new tasks to help you understand what is going to happen and how and why you need to do everything **before** you go to the airport.

Next to each new item in the **Content** section, we provide study unit-level references to read in *Instrument Pilot Flight Maneuvers and Practical Test Prep* (FM) and the section to read, if appropriate, in your airplane's Pilot's Operating Handbook (POH). You can make use of the comprehensive index in the Gleim books if you need to analyze specific task element-level details.




Figure 13. – Microburst Section Chart.




Figure 24. – En Route Low-Altitude Chart Segment.




Figure 31. – En Route Low-Altitude Chart Segment.




Figure 65. – En Route Low-Altitude Chart Segment.




Figure 66. – CDI and OBS Indicators.




Figure 67. – Localizer Symbol.




Figure 87. – En Route Low-Altitude Chart Segment.




Figure 89. – En Route Low-Altitude Chart Segment.




Figure 91. – En Route Low-Altitude Chart Segment.




Figure 95. - No. 1 and No. 2 NAV Presentation.




Figure 96. – Aircraft Position and Direction of Flight.




Figure 98. – Aircraft Position.




Figure 99. – HSI Presentation.




Figure 174. - GLEN ROSE Nine Arrival (JEN.JEN9).




Figure 192. - VOR/DME-B (PRB).




Figure 211. - STAKK Three Departure (STAKK3.STAKK) (HLN).




Figure 217. - ILS or LOC RWY 13 (DSM).




Figure 230. - VOR/DME or GPS-A (7D3).




Figure 234. – ILS or LOC RWY 18 (LNK).




Figure 238. - RNAV (GPS) RWY 28 (LHQ).




Figure 247. - ILS or RWY 9 (RAL).

### APPENDIX B: USE OF A FLIGHT SIMULATION TRAINING DEVICE OR AN AVIATION TRAINING DEVICE

A flight simulation training device or aviation training device can be an extremely important teaching tool in your instrument training. It can be used to teach the instrument scan, visualization of position, holding, and the approach procedures far more efficiently and cost-effectively than an airplane. These devices can be stopped in mid-flight to allow discussion of problems and can be reset so that difficult portions of a procedure can be practiced repeatedly. Training received in a flight simulation training device or an aviation training device must be logged with an authorized instructor.

#### **Definitions**

- 1. **Flight simulation training devices (FSTD)** are full flight simulators (FFS) or flight training devices (FTD).
  - a. Full flight simulator (FFS) means a device that
    - 1) Is a full-size cockpit replica of a specific type of aircraft, or make, model, and series of aircraft
    - 2) Includes the hardware and software necessary to represent the aircraft in ground and flight operations
    - 3) Uses a force cueing system that provides cues at least equivalent to those cues provided by a 3° freedom-of-motion system
    - 4) Uses a visual system that provides at least a 45° horizontal field of view and a 30° vertical field of view simultaneously for each pilot
    - 5) Has been evaluated, qualified, and approved by the FAA in accordance with 14 CFR 61.4(a)
    - 6) Includes FFS levels A through D
  - b. Flight training device (FTD) means a device that
    - Is a full-size replica of the instruments, equipment panels, and controls of an aircraft in an open flight deck area or in an enclosed cockpit, including the hardware and software for the systems installed that are necessary to simulate the aircraft in ground and flight operations
    - 2) Need not have a force (motion) cueing or visual system
    - 3) Has been evaluated, qualified, and approved by the FAA, or has been authorized for specific use under 14 CFR 61.4(a) or (b), as appropriate
    - 4) Includes levels 4 through 7 (for airplane)
- 2. An **aviation training device (ATD)** is a training device, other than an FFS or FTD, that has been evaluated, qualified, and approved by the Administrator.
  - a. This includes a replica of aircraft instruments, equipment, panels, and controls in an open flight deck area or an enclosed aircraft cockpit.
  - b. It includes the hardware and software necessary to represent a category and class
    of aircraft (or set of aircraft) operations in ground and flight conditions having the
    appropriate range of capabilities and systems installed in the device for the specific
    Basic or Advanced qualification level.
  - c. ATDs cannot be used for practical tests, aircraft type specific training, or for an aircraft type rating.

#### d. A basic aviation training device (BATD) is a device that

- 1) Meets minimum acceptable criteria of AC 61-136A, Appendix 2, BATD
- 2) Provides an adequate training platform and design for both procedural and operational performance tasks specific to the ground and flight training requirements for Private Pilot Certificate and instrument rating per 14 CFR Parts 61 and 141
- 3) Provides an adequate platform for both procedural and operational performance tasks required for instrument experience and pilot time
- 4) The FAA finds acceptable in a manner described in AC 61-136A

#### e. An advanced aviation training device (AATD) is a device that

- 1) Meets or exceeds the criteria outlined in AC 61-136A, Appendix 2, BATD
- 2) Meets or exceeds the criteria outlined in AC 61-136A. Appendix 3. AATD
- 3) Provides an adequate training platform for both procedural and operational performance tasks specific to the ground and flight training requirements for Private Pilot Certificate, instrument rating, Commercial Pilot Certificate, Airline Transport Pilot (ATP) Certificate, and Flight Instructor Certificate per Parts 61 and 141
- 4) Provides an adequate platform and design for both procedural and operational performance tasks required for instrument experience, the instrument proficiency check, and pilot time
- 5) The FAA finds acceptable in a manner described in AC 61-136A

NOTE: An AATD, however, may be used for some of the required tasks of an instrument proficiency check (IPC).

#### **ATD Approval for Part 61**

- 1. To be approved for use for pilot training and experience requirements under Part 61, an ATD should
  - a. Be capable of providing procedural training in all areas of operation for which it is to be used
    - Those tasks should be specified in an acceptable training curriculum or as authorized by the FAA and meet the description and suggested criteria outlined in AC 61-136A, Appendix 4.
  - b. Have the Letter of Authorization (LOA), Qualification and Approval Guide (QAG), and performance information for the aircraft configurations being represented
- 2. For more detailed information about ATDs, refer to FAA AC 61-136A, FAA Approval of Aviation Training Devices and Their Use for Training and Experience.

#### **ATD Approval for Part 141**

1. Notwithstanding Part 61 criteria, the local Flight Standards office may approve an ATD as part of an overall Part 141 school curriculum approval and certification process.

#### Part 141 – Appendix C Instrument Rating Course

- 1. Instrument training in a simulator may be credited as follows:
  - a. FFS: Up to 50% of the required course hours can be logged.
  - b. FTD: Up to 40% of the required course hours can be logged.
  - c. AATD: Up to 40% of the required course hours can be logged.
  - d. BATD: Up to 25% of the required course hours can be logged.
  - e. Combination ATD and FTD: Up to 40% of the required course hours can be logged (notwithstanding BATD 25% limit).
  - f. Combination FFS, FTD, and ATD: Up to 50% of the required course hours can be logged (notwithstanding the FTD 40%, AATD 40%, and BATD 25% limits).
    - 1) The device must be approved and authorized by the FAA.
    - 2) The FAA must approve the instrument training and instrument tasks performed in the device.
    - 3) An authorized instructor must provide the instrument time in the device.
    - 4) The ATD must be used in conjunction with an FAA-approved integrated ground and flight instrument training syllabus.

#### Part 61 – Instrument Rating Course

- 1. BATD: maximum of 10 hours
- 2. AATD: maximum of 20 hours
- 3. Combination FFS, FTD, ATD: maximum of 20 hours
  - a. The device must be approved and authorized by the FAA.
  - b. The FAA must approve the instrument training and instrument tasks performed in the device.
  - c. An authorized instructor must provide the instrument time in the device.
